2026 interim water rates application

Proceeding 30485
EPCOR Harmony Inc.

EPCOR Harmony Inc. (EHI)¹ filed an application with the Alberta Utilities Commission for approval of its 2026 interim water rates. The application, and any associated documents, are publicly available and can be accessed from the eFiling System on the AUC website: www.auc.ab.ca. EHI has applied for 2026 interim water rates, effective January 1, 2026. The applied-for rates include an interim refundable rate increase of five per cent over the 2025 approved rates set out in Decision 29203-D01-2024.²

EHI previously filed its 2026-2027 water general rate application, on September 2, 2025, in Proceeding 30249. That application is currently under review by the Commission. Because a decision on that application is not expected prior to January 1, 2026, EHI filed this interim rate application.

Interim rates are temporary rates implemented while the Commission reviews a utility's application for final rates. An interim rate approval specifies the effective date and the level of the interim rates. Once the final rates are approved, a true-up occurs. The utility calculates the difference between amounts collected under interim rates and what would have been collected under final rates. The difference is either refunded to or collected from customers. Prior to implementing the refund or collection, the utility must file an application for Commission approval of the true-up calculation.

SIPs are due December 15, 2025.

- A description of your interest, or the interests you represent, in the proceeding.
- A description of the issues you have identified with the application and your position on those issues.
- The process steps (such as information requests, intervener evidence, argument, etc.) that you believe are required to address the application and supporting reasons for why those process steps are required in this case.
- Whether or not the application could be amenable to a negotiated settlement process.
